**Surcharge for late, incomplete or inaccurate statements**

Late, incomplete or inaccurate statements are regarded as failure to declare. In that case, Havenbedrijf Amsterdam N.V. and the municipality of Zaanstad will impose a surcharge on Inland Harbour dues for professional navigation. If the failure to declare is repeated within 180 days, the minimum surcharge will be increased.

The surcharges will be as follows: 100% on top of the appropriate rate, with a minimum of 125 euros (one hundred and twenty five euros) or 300 euros (three hundred euros) or 600 euros (six hundred euros). The amount of the minimum surcharge is dependent on the number of times you have previously failed to declare Inland Harbour dues:

- no failure to declare in the last 180 days: € 125
- one failure to declare in the last 180 days: € 300
- failure to declare multiple times in the last 180 days: € 600
